Questionnaire to CTIF member nations and organisations on the subject of Forest and Wildfires

Introduction, by Mark Jones, Chair, CTIF Forest Fires Commission

At the recent CTIF delegate's assembly, I was privileged to address the assembly as the newly appointed chair of the forest fires commission. I stated my early intentions to develop a questionnaire that would establish the views of member states and to investigate and develop strategic partnerships to further the interests of the commission. I now attach the questionnaire and would be very grateful if you could arrange for its completion at your earliest convenience.

If you wish to forward it to other colleagues or organisations within your nation, I would be grateful to receive their responses.

Purpose of the questionnaire

The Forest Fires Commission receives varying levels of support from member states. In seeking to identify why this is the case, I am circulating this questionnaire with the intention of developing a business plan for the commission, which accurately addresses the concerns of member states.

In requesting the completion of this questionnaire, I would stress upon you the need for national level response – be sure that the responses received actually represent the views of your organisations, they will shape the strategy that is adopted by the commission and therefore need to accurately represent the real feelings and wishes of your nation. If you wish to copy the questionnaire to several respondents in your country, it may be helpful.

The findings of the questionnaire will be utilised for the purposes of:

- Developing specific terms of reference for the Commission.
- Contributing to innovations such as the handbook referred to below,
- Shaping future strategies, and
- Accurately assessing the position of each member state on this policy area

As I announced in Varzdin this July, I am attempting to gain EU support for a partnership with a German University for the purposes of production of a Firefighter's Safety Handbook for Wildfires. Whilst it is too early to predict if this bid is likely to be successful, if it proves to be successful, the views expressed within the questionnaire will help to shape the outcomes and contents of the final document.

I will aspire to conduct 2 meetings each year of the Forest Fires Commission. Meetings will be conducted at varied venues, and I will attempt, wherever



possible, to match the meetings with other related events and meetings. The next meeting of the Forest Fires Commission will be held in February 2006 (venue: to be announced).
