





# International Seminar on Planning and Prevention of Landscape Fires and the Role of Landscape Restoration

Santiago de Chile, June 20-21, 2019 Venue: Auditorium FAO Regional Office for Latin America and the Caribbean Av. Dag Hammarskjöld 3241, Vitacura - Santiago de Chile.

#### Overview

Initiative 20x20 is a country-led effort seeking to change the dynamics of land degradation in Latin America and the Caribbean by bringing 20 million hectares of land into restoration by 2020. The initiative launched formally at COP20 in Lima and supports the Bonn Challenge, a global commitment to bring 150 million hectares of the world's deforested and degraded land into restoration by 2020, and 350 million hectares by 2030, and the New York Declaration on Forests that seeks to restore 350 million hectares by 2030.

Currently, 17 Latin American and Caribbean countries and three regional programs have committed to begin restoring 53.2 million hectares (or about 205,400 square miles, an area roughly the size of France) of degraded land by 2020 through Initiative 20x20. Chile has pledged 0.5 million hectares to restore degraded landscapes and has implemented the first steps to plan the process including fire prevention and control.

The initiative is supported by more than 40 technical organizations and institutions and a coalition of impact investors and private funds deploying US\$2.45 billion in private investment.

The seminar will gather relevant information and experiences to develop strategies and plan at the national and local levels. As a product of this event the organization committee will produce a report to condense the key areas of forest fires prevention and control strategies and their relationship with landscape restoration.


