Presentation of the 12-month assessment review report within the framework of the project "Assessment of environmental impacts of the war against Ukraine and options for remediation"

The war against Ukraine has led to the **degradation of the environment** in many parts of the country, **exacerbating existing natural hazards, risks, and vulnerabilities**, and further exacerbating those associated with climate change in the country. The direct and indirect impacts of this war pose risks to the environment, human health, and security, not just in Ukraine but also in the neighbouring areas.

The aim of the OSCE project "Assessment of environmental impacts of the war against Ukraine and options for remediation" is to assess the environmental impacts of the war and contribute to the remediation of the damages to and the degradation of the environment in Ukraine, in order to address and reduce future safety and security risks.

The project results focus on:

- (i) Environmental impacts of the war against Ukraine are assessed and reviewed in coordination with national and local/municipal governments
- (ii) Government's planning tools for emergency action on environmental issues are enhanced
- (iii) Capacity of professionals / front-line workers on the emergency actions plans increased.

Since November 2022, the OSCE has started implementation of the activity 1) the development of the assessment of the environmental impacts of the war. The initial stage involved the development of a **12-months assessment review report**, in coordination with the national authorities, as well as with relevant international stakeholders and partners.

The aim of the project briefing is to present to the donors and interested participating States the results of the 1-year assessment review report and share the plans for future activities and next steps.
